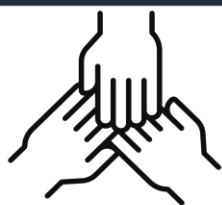

**2022 Treasurer's Annual Report (Calendar Year ending 31 December 2021)**

Calendar year 2021 was interrupted by COVID-19 although we still managed to hold our National Championships with a last-minute flurry of compliance activities in June. The IJRU World Championships was converted to a virtual event and resulted in some outstanding results for our athletes.

From a financial perspective our Financial Position resulted in a **NET PROFIT of \$2,800** compared to the expected **LOSS of \$17,431** in 2019. (Worlds year)

Skipping Australia continued to evolve its financial practices and we spent our planned budget with additional major investments as follows;

- IJRU ICT equipment (\$2600)
- Investing in judging qualifications prior to IJRU Virtual World Championships (\$7950).
- Replacement Australian uniforms when our chosen supplier declared bankruptcy due to COVID (\$3211).

Skipping Australia continued to use electronic accounting packages which saw invoicing and receipting maintained online with positive feedback from Clubs, Associations and Accountant.

A CY2023 budget will be created and approved by the Executive Committee in October 2022 following the AGM, with a review of identified expenses now we are emerging from the post COVID-19 environment.

Current Skipping Australia finances with effect 23 September 2022, situate us with an operating balance of \$35,934 and minor outstanding debts due to hosting the 2022 National Championships.
