
2020 Treasurer's Annual Report (Calendar Year ending 31 December 2020)

2020 was savagely interrupted by COVID-19 with our National Championships cancelled and the plans for IJRU World Championships delayed by 12 months. This delay meant we had no major income source for the FY (2020 National Championships) and our Financial Position resulted in a **NET LOSS of \$17,431** compared to the **PROFIT of \$2414** in 2019

Skipping Australia forged onwards, but with less activity, and we planned and replanned our IJRU WC and then virtual WC a number of times including paying for, then being refunded our nomination fees.

We spent our planned budget on IJRU ICT equipment and upgraded our website during the COVID period. This provided us with another engaging mechanism to communicate with our members.

Skipping Australia continued to use electronic accounting packages which saw invoicing and receipting maintained online with positive feedback from Clubs, Associations and Accountant. As always, we welcomecomments where we may be able to improve services.

A CY2021 budget was created and approved by the Executive Committee in January 2021, although themajority of plans for expansion, expenditure and competitions were postponed due to COVID-19.

Current Skipping Australia finances with effect 4 December 2021, situates us with an operating balance of \$16,189 with no outstanding debts.

We are anticipating to move back to normal operations (hopefully) as COVID-19 impacts abate
